- **9.1** Discussion and Action regarding the purchase of a pre-owned bus Director Damery received and reviewed 4 quotes from Central States Bus Sales. The bus we are looking at is a 77 passenger 2004 Blue Bird All-American transit style with 123,000 miles. It is priced at \$20,000. Central States is offering a one-year financing. Director Damery explained that \$10,000.00 has been budgeted; he would like to spend \$12,000.00 and make a \$6,000.00 payment towards the bus, and reserve the balance of that for the painting. Then pay off the balance of \$14,000.00 in May.
  - A motion was made to approve the purchase of a pre-owned bus with a 6 and 14 split pending that the bus meets our satisfaction after a test drive and check of maintenance records (Bremner, Baer; 3-1)
