# 10.2 Discussion and Action to purchase a dump trailer

Director Damery has secured bids for the purchase of a dump trailer. This dump trailer will serve two purposes. It will transport the CAT 259D and secondly provide an additional means to haul material. Director Damery checked with as many vendors as he could and received three quotes and recommended the purchase from Tucker Equipment Sales.

# 10.3 Discussion and Action to approve excavation and concrete walkway and curb at Meadow Valley Park

Director Damery received two quotes for excavation, concrete walkway and curb at MVP. These quotes came in a lot higher than anticipated partly because we ended up getting a larger playground due to a grant through Cunningham Recreation and a longer sidewalk that will connect to the walkway the dog park. Dan Schrock & Sons submitted a quote of \$19,452 and Lucas Construction submitted a quote of \$20,030.
