9.2 Discussion of the 2015 Tax Levy Ordinance for the 2016-2017 Fiscal Year

Director Damery presented to Commissioners a maximum levy request based on our needs and the Estimated EAV provided by the County Supervisor of Assessments. He explained that he sent it to the County Clerk asking for the PTELL Limits to be applied so Director Damery knows how the limits could affect the levy. Director Damery explained that last year we decreased our normal request to the benefit of our residents. It would be in our best interest to request a maximum levy this year based on the new growth and increased EAV to get back to where we would have been had we not been impacted by the tornado and residents will still see a tax rate reduction by about 3.5%. Director Damery will talk to the other Districts in town to find out how they plan to handle the levy this year. Commissioners supported the idea to proceed with the maximum levy request.
