# 9.0 Old Business

### 9.1 Discussion and potential action on the FY 2016-17 Working Budget

Director Damery explained that the hold up on the Working Budget has been better defining the WRA impact on the Recreation Fund and the Capital Fund. The negative income in the Corporate Fund is a result of adding health benefits for a full time employee and also a significant increase for tech support.

The Recreation Fund has a very healthy fund balance. The budget does include WRA revenues and expenses. Director Damery explained he is confident WRA board members will approve joining the park district and if for some reason WRA would not join us the Recreation Fund would break even. Some additional expenses to look at with this fund include: an additional athletic coordinator and a part-time adult program supervisor.

The Paving and Lighting Fund needs to be closed out. We will spend from this fund first for any paving projects in order to zero out the fund and close it.

Recapping the fund balances at the beginning of this fiscal year had a balance of \$787,000 with a revenue of \$3.4 million with potential expenses of \$3.64 million. The transfers in and out are generally the working cash transfers.

Directory Damery recommended that we use some of the \$300,000 plus fund balance from the Recreation Fund for Capital Projects. Director Damery went through and discussed projects listed in the budget that he would like done and asked Commissioners for any questions.
