# 8.3 Discussion and Potential Action on Bids for Harry LaHood Park Restroom and Emergency Shelter

Director Damery explained we are looking into subbing out this project through a construction management service. Director Damery stated he is talking to Kurt Hartter with Arch Masonry, who believes a block building will be just as strong as a concrete building. Director Damery asked Kurt how much he thought it may cost to build this shelter based off the original specs but as a masonry building. Kurt presented Director Damery with a quote. However, the cost does not include electrical, plumbing, sewer and paint/wall coverings. Director Damery further asked the engineering firm to confirm the masonry building as quoted could stand up to similar wind speeds. The engineering firm replied that it could withstand 250mph winds. Director Damery is working to get additional quotes on the other items and hopefully next month be able to move forward with the bid process for subcontractors.
